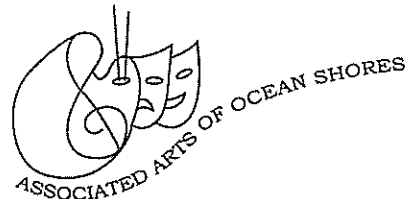
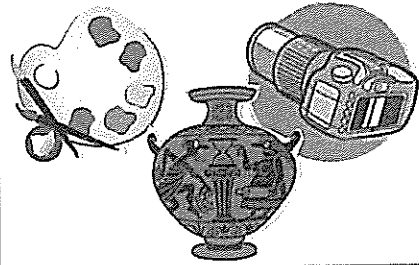

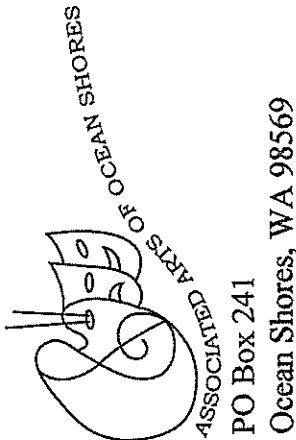
Eligibility:

Juried entries must be submitted for jury review as follows:

- JPG format via internet, or a CD by mail. CDs of submitted work will not be returned;
- Multiple images may be saved to one CD;
- Each image should indicate "artist's name, division, & title of work";
- Entries must be original work done entirely by the entrant;
- Entries must not be copies, in whole or in part, of paintings or photographs by other artists;
- Works must not have been done in workshops or under supervision;
- Entrants accepted in the juried divisions may not submit entries in the same division in the open show;
- Artists may not substitute their work nor withdraw an entry once it is accepted;
- AAOS reserves the right to refuse, upon arrival, any piece of unacceptable quality or work that does not match the previously submitted image;

Open Show Entries do not require a prior acceptance review.

- The Open Show is for those who consider themselves to be a hobbyist or an amateur, do not teach or instruct others, show their work in galleries, or considered to be a professional Artist or Photographer.

Acceptance:

You will be notified by email of your acceptance into the Juried Show. If you do not have an email address, please include a self-addressed, stamped envelope with your mailed submission.

Your acceptance will not be official until your entry form and check are received in the mail.

Conditions:

- All entries must be for sale;
- Maximum of six entries per person in the Juried or Open exhibition;
- All hanging art must be wired, saw-tooth hangers are not acceptable.

Sizes accepted:

Art - Maximum/minimum framed dimensions at least 12", but not to exceed 48" horizontal and/or vertical. Works larger than the maximum size will not be accepted under any circumstances.

Shipped Work:

- Entrant must pay all shipping costs, including a pre-paid return label to be included with the original shipped piece.
- Include in your entry check a \$10.00 handling fee per artist for shipped work.

Deadline for shipped work Monday April 17th.

Shipped art work will be returned within 2 weeks from the last day of the show, April 23rd. Unclaimed entries or those without return labels will become the property of AAOS after ten days.

Framing Guidelines:

Juried Fine Art and Photography

- Must be wired for hanging, saw-tooth hangers are not acceptable;
- Canvas wraps are acceptable.

Open Art

- Must be wired for hanging, saw-tooth hangers are not acceptable;
- Canvas wraps are acceptable.

Open Photography

- No frames or canvas wrap;
- Must be matted and secured to a foam board;
- Minimum/maximum outside Dimensions 16 x 20;
- Hangers will be provided for you to mount to your foam board if you do not have them.

Entry Fees:

Juried:

- Single entry: \$20
- Up to three entries: \$50
- Each additional entry: \$10

Open:

- Single entry: \$10
- Up to six entries: \$50

Entry fees are non-refundable

A maximum of six entries per applicant

Fine Art/Juried/Open

Oils, Acrylics, Pen and Pencil, Watercolor, Pastel, and two dimensional Mixed Media.

Photography

There will be no distinction between color, black and white, film, digital or electronic media.

All photography entries will be judged as one.

Three dimensional Categories

This art is not flat like two-dimensional art. It is observed in terms of height, width and depth.

Fiber Art, Wood Carvings, Leather Works, Metal, Stained Glass, and Sculptures.

Sculptures and free-standing work must be stable to stand alone. Hanging work must be properly wired to hang.
