**NOTE:** You must provide your own tables and chairs.

**Optional:** Food vendors may stay open after 5 pm while the musicians are playing.

**Please Note: Security will be provided Thursday, Friday and Saturday evenings.**

**Rules of the Show:**

1. Food vendors must be present and open for business by 10 am for the entire three days of the Festival.
2. A current business license is required to participate.
3. Food Vendors are required to apply for and receive their Temporary Food Permit for the Festival by July 15, 2025 and provide a copy to AAOS by email at [artsandcraftsaos@gmail.com](mailto:artsandcraftsaos@gmail.com).
4. Vendor agrees to the use of their name, and/or company name and any photos provided, for all AAOS Festival marketing and advertising. Vendor also agrees that videos and photographs taken during the event by Festival staff may be used for promotional purposes during the event and for future events, and are the property of AAOS.
